With over 15 years of experience, \$400 Million in annual revenue, and more than 180 deployments worldwide, Viisage and L-1 are ideally suited to capitalize on these flourishing markets as newly enacted laws such as the Real ID Act and global concerns such as international terrorism are extensively prevalent in today's world. Viisage and L-1 are answering this challenge by developing products such as ID-Suite helping to provide quick and efficient identity and document verification, ensure the public safety, and prevent identity fraud and theft.

What is ID-Suite?

ID-Suite is a patented and integrated hardware and software solution that provides identity and document verification across a variety of markets. The hardware solution consists of the B5000 and B5000-SC (the "SC" stands for "smartchip") document scanner (for documents such as RFID embedded e-passports and secure drivers licenses), and the smaller J1000 card reader (formerly the ID-Guard product). The software solution is a suite of applications that run congruently with the above hardware devices. Modules such as: ID-Examiner, Global ID, ID-License, ID-Passport, and ID Reference provide the human-interface by which to authenticate and adjudicate documents when necessary.

Viisage and L-1 will be launching this new integrated product on October 28th of this year therefore for the purposes of the pending product launch this *Messaging Guide* will deal with the valuation and market opportunities centering on ID-Suite in the DMV, Border Management, and Law Enforcement market sectors.

The new B5000 and B5000-SC are smaller, sleeker, lighter and faster than their predecessors. The B5000-SC (with its improved antennae design) has the enhanced ability to not only read passports but authenticate documents that have the embedded RFID chips in them. Both document scanners support faster customer processing and have a very small footprint which is ideal for environments where counter space is limited. Both the B5000 and B5000-SC also have the following enhancements:

- Ability to take advantage of L-1 leadership in automated document authentication as an option – now or later
- Automated document detection
- New method of holding document in place (“brushes”)
- Faster and more accurate reads of both RFID and non-RFID passports

The B5000 is a 5th generation technology—something our competition cannot say.

The new J1000 card reader is a breakthrough identity document authentication scanner that sets a new industry model in size, weight, performance and cost of ownership. The J1000 automatically scans document images, printed text and barcode/magnetic strip information and searches for and authenticates document security features using multiple light spectrums—without sacrificing accuracy or ease of use.

Funding for newly integrated digital deployments is coming, e-passports are here, and most agencies have held off their spending on readers. Furthermore, the new readers offer an upgrade path that allows the device to go from a simple reader to a document authentication system with a software upgrade.
